Mr. President and gentlemen

It gives me great pleasure to present this report the first since Feb 13th 1939.

On the whole it has been quite a busy year, we have rung for 8 weddings, 2 muffled peals and 1 honorary degree, in addition to ringing for the confirmation service and half muffled for the late Mr Fern. I think only one or two Sundays in the whole year were the bells silent for evening service, but that was mainly due to holidays.

The standard of ringing has steadily improved and we can now raise a good ten bell band.

We have rung many quarter peals this year on 8 and 10 bells, but have not been successful in ringing a peal.

The outing this year, in my opinion, was a great success, in spite of the inclement weather everybody thoroughly enjoyed themselves.

The B.B.C. decided to broadcast St Benets bells on Xmas morning and I was asked to supply the ringers from St Marys band. Those that took part in the broadcast were rewarded by knowing that St Benets came over the air well.

Again on New Years eve the B.B.C. broadcast St Marys bells in the Canadian overseas service again, judging by a letter received from Canada St Marys bells were received with great enthusiasm.

I had great hopes of seeing our bells rehung in a steel frame, but as most of you know we have been waiting for Mr Lewis's report for 12 months.

THE SOCIETY OF CAMBRIDGE YOUTHS

RULES

1. That the Society be called "The Society of Cambridge Youths."
2. That the objects of the Society be the promotion of the art of change ringing and to ring the bells of St. Mary the Great for Sunday services and on the occasion of civic and University functions and events of National importance.
3. That the Society's Headquarters be in the belfry of St. Mary the Great, where all the property be kept.
4. That the Society consist of an unlimited number of Ringing Members, Honorary Ringing Members and Honorary Members under the direction of a President, Master, Secretary and Treasurer and a committee of three (four of this number to form a quorum).
5. That any person be admitted a member at any meeting of the Society, if proposed by one member and seconded by another and approved by a majority, but the votes of not less than five members shall be needful for election. All elections to be ratified at a general meeting of the Society after due notice has been given. No ringer shall be admitted a member unless he is able to ring at least three courses with a working bell in a seven or eight bell method.
6. (a) That Ringing Members be those who normally attend for Sunday service ringing and shall pay an entrance fee of 5/-.
(b) Honorary Ringing Members to be those who do not normally attend for Sunday service ringing and shall pay a life subscription of 10/6.
(c) Honorary Members to be non-ringers who contribute to the Society's funds at least £1 1s. 0d.
7. That probationers be admitted to the belfry and instructed and when qualified under rule 5 be admitted to membership in the ordinary way.
8. That an Annual General Meeting be held during the month of February, when the officers described in rule 4 be elected for the ensuing year. The business of the Society to be conducted by ringing members only.
9. That at all business meetings the President act as chairman. In the absence of the President, the Master shall act in his stead; if both President and Master be absent, a member shall be elected as chairman by a majority vote. On all matters the chairman shall have the casting vote.
10. That the Master be responsible for all ringing by the Society and for all the property of the Society and that on taking office he check the articles given into his charge with the schedule appended to these rules and report any deficiencies to the Society.
11. That the Secretary and Treasurer keep a record of all meetings of the Society, that he give fourteen days' notice of all business meetings, and that at the Annual General Meeting he shall present a report and balance sheet that has been audited previously by a Ringing Member appointed for that purpose.
12. That on the written request of not less than three members, the Secretary be empowered to call an extraordinary general meeting of the Society within 28 days of such request.
13. That members meet for practice on Monday evenings at 7.30 p.m. (Bank Holidays excepted) and on Sunday evenings at 5.30 p.m. or as previously arranged.
14. That on occasions of ringing for payment, 80 per cent of the fee be equally divided among the ringers participating; the remaining monies shall accrue to the general fund.
15. That the property of the Society shall not be taken away from the tower without the consent of the Master and one member of the committee. Any member having such permission shall be held responsible for its safe return.
16. That for any breach of the Society's rules or for any misconduct in the belfry a member may be fined or expelled upon a decision by a majority vote of members present at a general meeting held for that purpose.
17. That no rule be altered, added or rescinded except at the Annual General Meeting, when due notice of the proposed alteration has been given, nor without the consent of two-thirds of the members present.

Between 1969 and 1974 the Society continued to ring regularly for services at GSM with FE (Frank) Haynes as Ringing Master and JWR (Jim) Quinney as Secretary and Steeple Keeper. The Monday practice and summer outing were also maintained. Ringing was sometimes limited to smaller numbers but Stedman Cinqes and Cambridge Maximus were regularly performed throughout the period. Following Jim Quinney's death in office, Ian West was elected Secretary in 1974 (Youths minute book must have this date on record). The bells and frame were inspected by BD (Brian) Threlfall in (something like 1975) and a programme of painting and minor repairs, including installation of sound control was led by Ian West.
