Annual General meeting - Monday 27th February 1995 in

the Ringing Room, Great St Mary's

The meeting opened at 8.10pm with the President (elect) in the chair.

1. Apologies for absence were received from Clive O'Callaghan, Christopher Johnson, Linda Garton, Malcolm Edwards, Liz Orme, Jonathan Shanks and Hannah Worr.
2. The minutes of the 1994 AGM were read and approved (Prop. Lesley Bayle Seconded Andrew Daws).
3. Mates Aising: R.M.Brown said she had been unable to donate a carpet (it was now in her new house). She also said she had not proposed the rule change discussed one year before, as the general feeling of the meeting had been against it. FH King raised the question of the church budget. The secretary stated that no ringers' budget had been requested. The President said that the church treasurer had changed and the lack of request was probably an omission. MDO'Callaghan highlighted that as the bells belong to the church fabric Great St Mary's should continue to contribute. It was noted that an extraordinary general meeting had taken place and agreed that a report of the meeting should be appended to the AGM minutes for approval at the next meeting (prepared by the officers).
4. The following were elected as members of the society -

The elections of Mark C Liebenrood and Adam W Kiger following prior attempts were ratified (Prop. B.M.Johnson Sec. P.S.Seara)
5. FH King stated that he had not audited the accounts fully, but would be willing to sign them. It was agreed that Tim Kiger, B.M.Johnson, MDO'Callaghan & FH King should review both the 1993/4 and 1994/5 accounts and post display a notice on the tower noticeboard. A proposal to receive the accounts, to be adopted in 'matters arising' at the next

agreed to donate £175 to the Guy DA Central Bell Fund - proposed PLHBrooke sec. CESKugur (An amendment to donate £150 was defeated).

6. Master's report. The Society's archives were discussed. The master said he had arranged for the society to view the archives on 15th May 1995. PLHBrooke asked whether the County Record Office had found the money to buy the missing account book. The master said it had not yet been decided. It was suggested that the Society should own the book, and JPLevett asked who the current owner was. FHKing suggested the Society should be told if it wasn't possible to bring the book back to Cambridge. The volume covers the period when tower & belfry were recast and is therefore important in Cambridge Towns history. Action: The President is to write to the County Archivist.

The meeting thanked the master for his work over the year.

7. Belfry Maintenance Officer's Report. Solutions to the oddness on the gong were discussed. P.S.Seaman had contacted Whitechapel re: handbook quote, and proposed the same arrangement as last year (seconded FHKing). Namely:

If the cost is less than £300 the work should go ahead.

If the cost is £300-600 an executive decision should be made by the officers. The motion was carried.

FHKing asked about the relative costs of repairing/replacing ropes. CESKugur asked to be authorised to buy some ropes at ~£110 each. PLHBrooke proposed, seconded PMOrme that 6 ropes should be purchased or repaired as appropriate (carried). The treasurer will liaise with the church treasurer re:

claiming \* 50% of the cost from the church. MRDO'Callaghan emphasised that the ropes are a church responsibility to which the Society contributes.

The meeting authorised the Belfry Maintenance Officer to spend up to £50 to repair the recording equipment. Prop. PLHBrooke sec. RM.Brown. RM.Brown also suggested the church should be

9. Read Attempt Auction. Requests were received from CUC, Mark Regan, Nickey Crichton, Peter Sawyer and Ken Hesketh (although he had specified a date in July 1996). ALBrooke requested more notice of local peers and suggested more local peers annually. As the general feeling of the meeting was in favour, only 3 usual attempts were auctioned to CUC, Mark Regan and Nickey Crichton. Prop. ALBrooke sec. LHMBoyle. The secretary is to write to Ken Hesketh and explain the auctionation procedure. Peter Sawyer is to be encouraged to apply next year. The list of peer dates will be circulated to the Senate House, King's College and the President. The President said he would consider auctioning us more than 3 peers a year if required.

10. It was proposed by BRMJohnson, seconded FHKing that Rule 7 should be amended to read:

"members shall be entitled to make proposals and to vote at meetings only if they have rung at Great St. Mary's for at least twelve Sunday Services, for which ringing has been organised by the Society, in the previous calendar year."

The motion was passed.

11. Any Other Business.

TM.Kugur proposed, seconded PLHBrooke that the wedding fee should be increased to £75. Carried.

BRMJohnson raised the question of an annual donation to the church. The meeting believed the tower repairs had been fully funded and the £1000 donation should not be made.

EXTRAORDINARY GENERAL MEETING to discuss the repair or replacement of the cracked 9th bell. Wednesday 30th March 1994 in the Ringing Room, St. St. Mary's at 8pm. The Master, Mr. Barry RM Johnson in the Chair.

Mr. Frank H King described a proposal to construct a trap door in the roof which would enable ~~the bell to be~~ a crane to remove the existing bell for repair. Some members were concerned that welding might not be a long-term solution and that the Society should investigate replacing the 9th with a new bell. There was some anxiety that a new bell might not fit in with the existing ~~bells~~. It was further suggested that as the majority of the bells were cast at the same time as the 9th, it was possible that other bells might crack and need to be replaced in the foreseeable future. There was some discussion as to whether the Society should consider establishing a fund with a long-term view to replacing the entire ring, but members were generally in favour of preserving the present character of the bells.

Mr. King was hopeful that the church would be re-insured by the University for the cost of the repair (est. £4,100) but it was felt that, even if the cost had to be borne by the Society, we should proceed as soon as possible. A proposal to proceed with the repair of the bell by welding was passed by a large majority of those present.

EXTRAORDINARY GENERAL MEETING on Monday 31<sup>st</sup> July 1995

ANNUAL GENERAL MEETING held on Monday 26<sup>th</sup> February, 1996 in the Ringing Room, Great St. Mary's, starting at 8.10pm with the President in the Chair.

1. Apologies for Absence were received from JD Sherwood, EA Orme, MS Edwards, HM Woor, CO O'Callaghan.
2. Minutes of the meetings on 30<sup>th</sup> March 1994, 27<sup>th</sup> February 1995 and 31<sup>st</sup> July 1995 were distributed, read, amended, agreed and signed. The <sup>part</sup> sentence 'Sandweld of Lode to use' was deleted from the minutes of the March 1994 meeting. (Prop. PCH Brooke, Sec. PM Orme.)
3. Matters Arising
  - The Society's handbells have now been repaired by the Whitechapel Bell Foundry.
  - The missing account book has been bought and is now owned by the County Record Office.
  - The recording equipment is now in reasonable working order, but may need more attention.
  - After some confusion, it was agreed that the 1993/4 Accounts were 'transcribed' by FH King (not 'reconstructed') and that the 1994/5 Accounts should be adopted by the meeting following FH King's audit. (Prop. PS Seaman, Sec. LHM Boyle.)
4. New Members. There were no new members for election or ratification.
5. Treasurer's Report G Brown said that although the 1995/6 accounts showed a worse financial position than the 1994/5 accounts, she had just received a substantial cheque from the Church Treasurer covering 50% of the previous year's expenditure on bellropes. This was greatly appreciated. After lengthy discussion, during which MHD O'Callaghan wished to make it clear that bell maintenance costs were the church's responsibility (to which the ringers contributed), it was agreed that S Brown as Chairman of the Property Committee should ask the Church Treasurer to write to FH King before November each year formally requesting a budget from the ringers. Dr King would also be invited to the next Property Committee Meeting. G Brown said that in future the Belfry Repair Fund and the General Account would be combined. It was noted that

6. Master's Report BRM Johnson highlighted the Society's victory in the National 12-bell, Cambridge District and Ely D.A. Mr. Johnson also thanked Mrs. Brown for agreeing to become Secretary/Treasurer at short notice and reported that the Society had been invited to ring at Westminster Abbey on January 1 1997.
7. Belfry Maintenance Officer's Report, CEJ Kilgour reported that there were no major problems with the bells; that the frame and paintwork are still in good order; that he anticipated having to replace 2-3 ropes in the next year. Mr. Kilgour was given the go-ahead for these essential purchases.

1. Apologies for Absence were received from Revd. J Binns, LM Gaffon, BM Johnson and EA Orme.
2. Minutes of the meetings on 24.2.97, 16.6.97 and 6.10.97 were distributed. The word 'short' was deleted from the minutes of 6.10.97. All three sets of Minutes were agreed and signed. (Prop. AW Kilgour, sec. PM Orme.)
3. Matters Arising
  - No budget had been requested by the Church, but the Secretary said she had written to the Treasurer to submit likely costs for the coming year.
  - The Society's records should be completely renovated by the summer of 1998.
  - The Belfry Maintenance Officer confirmed that twelve new ropes had been received during the year which had all been fitted. The further set of twelve new tail ends had been ordered and had just been received.
  - FH King said that although he had been invited to a Property Committee meeting, the subject of air-conditioning and supply of electricity was not raised.
  - The Secretary reported that she had written to the church to say that the ringers were no longer able to run the tower as there had been a poor response to her last request for volunteers.

6. Master's Report. PCH Brodie expressed his regret in taking over from PS Seaman but thanked everyone for their support. He had tasked a written report, but asked for general comments on the past year. FH King said he had found the 'tick lists' used in BHM Johnson's term of office very helpful, and the Master said he would consider using these again, even if the job was delegated. Monday evening practices were now being recorded on tape and it was agreed the judicious use of the playback facility might be worth an experiment.

- A quote of approximately £600 had been obtained for the laying of carpet tiles to the Ringing Room floor, but no decision was reached.
- A New Ring of Bells. FH King had prepared a preliminary document entitled 'A New Ring of 13 Bells for Great St. Mary's' following the previous year's work on the bells. Several members (including CHP Johnson and JD Shanklin) expressed the opinion that there could be many more years of life left in the current ring and that, given the constraints imposed by the location of the University organ, it was unlikely that either the 'go' or the clarity of the bells would be improved. PM Orme said he was all for it as a general idea, but agreed with JP Lovelock that a great deal of work would need to be done regarding founder, acoustics etc. PCH Brodie felt there was no need for urgent action, but that investigations could begin to form a contingency plan. G Brown felt that the band had fluctuated in its strength over the past 20 years and that, as it was currently very active, it was sensible to consider a new ring at a time when there was a group of people able to carry such a project forward. JD Shanklin was concerned that the tower might not last as long as a new set of bells. CEJ Kilgour warned that the Church was considering an application to English Heritage to fund work highlighted by a recent quinquennial report. Various stories had circulated about problems associated with this Department and CEJ Kilgour undertook to find out.

## THE SOCIETY OF CAMBRIDGE YOUTHS

Established 1724

Rules adopted at the Annual General Meeting in 1999

1. The Society's objectives shall be to promote the art of change ringing and to ring the bells of Great S. Mary's on Sundays and on days of Civic, University or National importance.
2. The Society's headquarters shall be the ringing room of Great S. Mary's. All Society property shall be kept there, except as agreed at a meeting.
3. The following Officers shall be elected: President, Master, Secretary/Treasurer and Belfry Maintenance Officer. The President shall normally be the Vicar of Great S. Mary's. An Auditor for the Society accounts shall also be elected.
4. The Annual General Meeting shall be held on a Monday in February or March, the date being at the discretion of the Secretary/Treasurer. The Officers shall be elected at this meeting.
5. An Extraordinary General Meeting may be called either by the President acting alone or on the written requisition of at least three Members who are entitled to vote. In each case a minimum of fourteen days' notice shall be given.
6. A person may be elected a Member at any Meeting of the Society, if proposed and seconded by Members, with a majority of Members present in favour; at least five votes in favour are needed. Any elections other than at a General Meeting must be ratified at the next General Meeting.
7. Members shall be entitled to make proposals and to vote at meetings only if they have rung at Great S. Mary's for at least twelve Sunday Services, for which ringing has been organised by the Society, in the previous calendar year.
8. The President shall preside at meetings when he is present. In his absence the Master shall, if present, act as Chairman. If both are absent a Member shall be elected to the chair. The Chairman shall have a casting vote.
9. The Master shall be responsible for the Society's ringing and property.
10. The Secretary/Treasurer shall record all General Meetings. He shall present a report and audited accounts at the Annual General Meeting. He shall keep a record of attendance at Service Ringing for the Society's use.
11. On occasions of paid ringing any part of the fee which is not divided among the ringers shall be added to Society funds. The distribution shall be determined on each occasion by the Secretary/Treasurer.
12. No rule shall be altered, added or deleted except at an Annual General Meeting. Fourteen days notice of any proposed amendment must have been given. Two thirds of the Members present and entitled to vote must be in favour.

#### The Society of Cambridge Youths - A Review

As we approach the end of the twentieth century, one of the frustrations about reviewing the archives has been the lack of personal information contained in them as it would have been great to be able to read about the sort of things the ringers at Great St. Mary's did, both in the tower and out of it. This, then, is an attempt to provide a 'snapshot' of ringing activity at the end of 1999.

#### Our Typical Year

Our regular ringing comprises two sessions on Sundays (8.45-9.30am for the family service and 5.30-6.30pm for Evensong) and our Monday night practice (6.30-7pm for learners and 7-9pm for everyone else). During term time the Cambridge Youths are responsible for morning ringing and Cambridge University Guild of Change Ringers (The Guild) ring for Evensong. Out of term, The Youths undertake ringing for both services. Generally speaking, we are able to ring all twelve bells, except for Evensong out of term where we sometimes struggle even to ring six!

This pattern continues throughout the year and is only interrupted

stop practising. In the past, we have ceased ringing from the end of April until mid-June, though this has reduced down a little in recent years without complaint.

We ring approximately eight peals each year, though three of these are reserved for visiting ringing bands and one for the Guild. They all take place out of term and the start times are generally in the late afternoon to avoid antagonising the traders in the market square. We currently charge £5 per rope for visiting bands. We try to schedule Sunday luncheon quarter-peals after Matins once a month during the winter, though it is becoming increasingly difficult to persuade those that live out of town to travel in more than once on a Sunday; particularly now that parking restrictions are so severe in the town.

There is a continuing schedule of University dates to be rung for which are arranged by the University Bellringer, Frank King. These include ringing for University sermons, for the Honorary Degree Congregations and various royal anniversaries such as the Accession of H.M. Queen. We receive a payment of approximately £70 per annum from the University for this. Technically, ringers are entitled to £50 per session, though in reality, this rarely gets returned to 'the box' as a donation.

In common with other churches, we do not ring during Holy Week, but we have recently introduced handbell and churchbell ringing for the Easter Dawn Service. Fortunately, there are currently approximately ten ringers who also worship at the church so we have been able to keep this up, despite the anti-social 5.30am start!

There are not many weddings in the church, though we are usually called upon for three or four each year for which we charge £75 - paying £5 per rope to the ringers. What with other special events, such as ringing for special services, this means that the bells are rung on about four or five occasions each week; no small commitment for the Master,

The year ends, of course, with ringing at midnight on New Year's Eve. At the time of writing, we haven't made final plans for the millennium eve, but a party is certainly in the offing.

#### The methods we ring.

Because of the regular influx of University Students, we are able to maintain quite a high standard of ringing which regularly includes Stedman Cinques, Bristol Maximus and, from time to time, Orion Surprise Maximus. The latter isn't always possible on a Sunday, but it is unusual for us not to ring twelve fairly competently. The band was at its strongest for Method, Churchbell and Handbell ringing during the late-eighties to Mid-nineties. The combination of talent and enthusiasm led to a series of four victories in the Taylor Twelve Bell National Competition. The band throughout this period rang together very regularly indeed and changed little over the years. Recently this has changed, with many moving away or taking on family commitments. Our achievements may not therefore be quite so stately, but it has led to much more of a welcome being extended to Guild members which has resulted in much less of a 'them and us' atmosphere in the tower. Our method capabilities have not diminished, but our striking is not quite what it was!

#### Customs and Practices.

- We ring the clock bells up and down before and after each session (3, 4, 5, 8 and 12) and make sure the hand control is on for non-sacred ringing.
- We regularly have about four or five visiting bands during the summer months (out of term only) charging £15 per band for the privilege.
- Frank King is now in his 22nd year of organising Ringing Demonstrations. By advertising in the Church (and previously in the Cambridge Festival Diary) Frank contributes up to £1,000 each year by inviting guests (mostly tourists) to watch a demonstration in the tower at 5.30pm each day for a fortnight. Traditionally, those ringers

The highest-scoring ringers are invited to a free curry when the demonstrations are over! Frank's remarkable achievement is set down in an Ode, penned by Gareth Davies, hanging on the ringing room wall. After so many years, the script for the demonstrations can be recited by most of the ringers taking part.

- The Cambridge Youths' AGM is usually held on the first Monday in February with the President in the chair. The conditions of membership of the Youths have varied over the years, but currently it requires a commitment to regular Sunday service attendance, where 'regular' means at least twelve times in any year. Those who continue at this rate are listed in the Attendance Book by name, (kept up-to-date by the Secretary/Treasurer). Those who cannot be so committed are referred to by their initials only.

- Until quite recently, teaching in the tower was a distinctly ad hoc affair. Now, however, there are upwards of half-a-dozen people learning from scratch (aged nine to... well, let's just say, retired) under the tutelage of Patrick Broome, Jonathan Hankin and Martin Bright.

- The Box - has been a feature of Cambridge Youth' ringing for many a year. A padlocked, metal monstrance which sits in the middle of the ringing room on the table, it is there to receive cash donations from Monday nights, visitors etc, and is the responsibility of the secretary/Treasurer. Fines for misdemeanours are no longer made, though alas, payment to a cleaner is also not made, this task being sporadically taken on by the University Bellringer and secretary/Treasurer when the build up of dust becomes too great.

- A recent addition is the Cambridge Youths' website; so now it can hardly be called a custom nor a practice. However, along with the facility to email almost every towerer, it has made an enormous difference to the officers in their ability to communicate quickly and easily with the ringers. The website is maintained by John Sturley.

- The noticeboard, generally goes unnoticed! It does serve, however, for details of Ely DA ringing, copies of the rules etc, but otherwise is hardly consulted at all.

we maintain a good, but occasionally tense relationship, most particularly when they wish to record in the Chapel and the sound of our bells intrudes. Notice of all peals is sent to them and the Senior Assistant Ringers in Devere House once peals are booked into the Church's diary and we receive regular updates of their schedule to avoid clashes.

- Sunday morning prayers have become a regular feature under our current President, Rev. John Birns. He mounts the staircase before ringing begins on most Sundays and his support in this and in many other ways, is much appreciated.

### Social Occasions

- During the exam term, various activities are organised by the Master to fill in the Monday night gaps when ringing at Great St. Mary's is suspended. Visits to surrounding towers such as St. Neots, Bury St. Edmunds, Ipswich, Thaxted etc are regular, as is an evening spent punting. In recent years, a competition between the Youth and the Guild has taken place, varying from cricket to a pub quiz and even laserquest on one occasion!

- It has been common practice to have a tower outing each year and these have varied from one-day tower grabs (e.g. in Suffolk arranged by John Loveless or recently to London) to longer weekends, staying overnight (e.g. in Exeter, Bakewell and Norwich)

- An informal dinner has often been held each year though this has often simply meant a get-together in a local Indian or Chinese establishment. More elaborate plans have involved an evening at Anglesey Abbey or a fund-raising 'house-to-house' supper.

- Of the greatest importance is, of course, the pub after each practice. Currently, we are patronising The County Arms opposite Shire Hall. Although it involves a hike from the tower it has the twin advantages of offering seating and food after 9pm - quite a rarity in Cambridge. In previous years we have used the Sir Isaac Newton and The Ancient Druid, near the Grafton Centre.

together after Sunday morning ringing. This used to take place in various ringers' houses, but with so many people unable to afford a central Cambridge location, this has now gravitated to The Copper Kettle at King's Parade where tea, coffee and egg & bacon rolls are consumed with great gusto.

As a final word the President made it clear that anyone organising peals for the Cambridge Youth in the future should only ask those who were members or those who "qualified" for membership. PLH Brooke pointed out that peals could always be rung for the Ely DA.

### 5. Treasurer's Report

The general account was explained to be the total of the current and high interest accounts. JK Hobson explained that the peal income was lower than in previous years due to the cancellation of the two visiting bands. She also explained that with the new payment for weddings, often no money went in to the account since all the income was paid to the ringers. Following no more questions the report was adopted unanimously. (prop. CTB Help)

### 6. Master's Report

JR Johnson distributed his report, and in addition commented that we had rung twice as many quarter peals as last year. We had rung fewer peals but he felt this not to be significant. - A new set of ropes had been ordered from Ellis and CO;
- Cleaning had not taken place this year; and
- He commented that the Accelerometer test results had seemed high.

JD Shanklin sought clarification of the process for ordering ropes. CTB Helps explained that we order them, they tell us the cost and we confirm or reject the offer. G Brown has the results of the Accelerometer tests, the tower is moving but not

"the orbit was contained in a circle less than 1mm in radius". Surprise was expressed. The President confirmed that the last Quinquennial report was less than 5 years ago. JD Shanklin said that when he held the post of Belfry Maintenance Officer it had been suggested that the frames were derusted and painted, this had possibly never been done. JD Shanklin proposed that noting the smaller income over expenditure in the minutes we should donate £200 to the Ely DA. This was carried unanimously (prop. JD Shanklin, sec. JCG Sturdy).

## 11. Any Other Business

- BRN Johnson asked for an update on Michaelhouse. The President explained that work was on track, and although various problems had been encountered they were expecting to open on 30<sup>th</sup> September this year. There was still a

lack of finance for the building work taking place.

- The President offered an enormous thank you to the Society for all their work during the year, in particular at their family wedding, but also for Sunday service ringing and for what we contribute to the life of Great St Mary's.
- FH King expressed concern about the Ely DA Subscriptions; none had been collected this year. It was agreed that the current arrangement for collecting subscriptions was unsatisfactory and it was suggested that the delegated treasurer look into the matter further.
- PLH Brooke brought up the subject of the pressure of time on practice night, and talked about the idea of a ringing simulator that would provide scope for extra use of the bells for practice. He felt that with the number of current learners and with many to come such a system could be useful. The possible cost would exceed £1000 but PLH Brooke believed that a budget of £6000 would be sufficient. PLH Brooke did not want to vote on the matter now since installing such a system would require a large time commitment from many people. A discussion followed on how the system could work and AL Brooke suggested that interested parties visit Balsham where such a system was in place. In general the meeting were in favour, and PM Orme offered to put something on paper to circulate following discussions with David Eagley. It was decided that an EGM would

appropriate way forward. PLH Brooke suggested a Statement of Intent on the part of the meeting to approve, in principle, the installation of a simulator and to request that PM Orme and PLH Brooke investigate further. The question was raised about the impact on bellringing at GSM of the Child Protection Policy. This was in response to concerns expressed by the Cambridge Youths following recent articles in the Ringing World, which suggest that compliance could prove burdensome. John Binns explained GSM's policy on this important matter, which is founded on a "common sense approach". In summary:

1. If parents are present they are responsible for their own children.
2. If parents are not present a nominated responsible adult must be there, who needs to be Criminal Records Bureau checked.
3. for youth training sessions there should always be a minimum of 2 adults present, both need to be CRB checked.
4. Any adult who has direct contact with children

Patrick Brooke offered to act as the liaison point between the bellringers and the Church on this matter. This offer was accepted.

Patrick Brooke pointed out that the guidelines followed by bell ringers are driven primarily by the need to comply with requirements under the Health and Safety at Work Act. John Binns mentioned that GSM has recently carried out a safety risk assessment; he will ensure we are provided with the relevant guidelines on managing safety risk

(b) Structural survey of the existing installation for the bells

Frank King confirmed that Harry Windsor will be visiting GSM during April to carry out a structural survey of the existing installation for the bells. We will receive a short report presenting his views on the condition of the installation and possible future options for the bells and its frame, this report will be circulated to all interested parties including the Church. Frank King stressed that the survey is purely investigative; the findings do not have to be acted upon.

The cost of the survey will be in the region of £250. It was agreed to make up to £300 available to Frank King to cover all costs associated with carrying out the survey (proposed: Patrick Brodie, seconded: Phil Orme).

The results of the questionnaire were circulated in advance of the meeting (see separate sheet). The main comments from the floor are given below:

Philip Orme thanked Barry Johnson for producing the questionnaire, which has proved popular. He started discussions by outlining his views on the purpose of this exercise. He said that being an active band today gives us the opportunity to investigate and consider options for the future of the bells. Broadly speaking, these options range from continuing what we do today, doing some more substantial maintenance, or doing some major work.

Barry Johnson thanked Liz Orme for putting the analysis together in a very readable form. Barry expressed his keenness to put forward some further investigations of our options (e.g. simulation of different arrangements of bells in the tower).

Jonathan Shanklin said that it is essential to get a point of view that new bells / frame will make things better. Patrick Broome pointed out that the reason for 11/16<sup>th</sup> turning the tenor

that the tenor is serviceable for some considerable time. Frank King pointed out that the 6<sup>th</sup> is quite badly worn and the 9<sup>th</sup> has been welded. However, it was noted that it ought to be possible to match both these bells with new ones in the event this is required, it is the tenor that would be hardest to match.

George Brown noted that:

- (a) the Church has recently had a major fund-raising activity (i.e. Michael House)
  - (b) Frank King has extensive links across the university that will be lost once he retires.  
These are important factors to bear in mind when considering if and when to undertake major work on the bells.

Chris Johnson noted that the results of the questionnaire responses indicate that we should consider doing something major.

Our President, John Binns, asked whether there is general support to investigate further our options. A proposal was put to the meeting that a sub-group is set up to investigate options and report back on findings.

(proposed : Phillip Orme, seconded : Barry Johnson)  
The proposal was carried unanimously, the sub-group to be convened by Phillip Orme.

It was confirmed that further investigations will consider a range of options, not just those that require major work.

12. Any Other Business

- (a) welcome pack for volunteers working with children.

Copies of welcome packs from the church office  
are with Liz Orme.

Frank King asked about the interviews the welca pack states will need to be held for all volunteers. It was agreed that we should get back in touch with the church office about an appropriate way forward.

#### (b) key holders

A list of bell ringing key holders has been produced along with the procedures for allocating responsibility for these keys to GSM ringers.

Frank King noted that each year at the Guild's AGM there is a handover to the Society of one set of keys to be used by them. Although this may seem trivial it serves an important purpose, reaffirming that it is the Society that is ultimately accountable for that set of keys.

### (c) Tower Procedures

Tower procedures have been prepared that provide details for getting in and out of the ringing room and bell chamber, preparing for ringing and leaving the bells once ringing has concluded. These procedures are especially

running the ringing and visiting peal bands.

#### (d) Safety procedures

As a follow up to the safety procedures prepared by the church some ringing specific "common sense" safety procedures have been drafted. These are still in preparation.

#### (e) Alumni weekend

John Binns mentioned that a University alumni weekend is being organised for the weekend of 24<sup>th</sup> September. They would like there to be some ringing at this event.

#### (f) PCC Representation

Patrick Brooke asked GSM ringers to consider whether they might be interested in becoming a PCC member. He noted that it has been very helpful having a ringer on the PCC (e.g. when discussions about the spire, mobile communications, child protection, etc. arise). Patrick will be standing down after 3 years on the PCC.

#### (g) Outing linked to fund raising for Christian Aid.

Jonathan Shanklin said that he would be willing to organise an outing linked to the fund raising event for Christian Aid on the first May Bank Holiday where you go to the highest point in each county. The highest points in Cambridge-

there was plenty of interest in this idea.
